

BROADCAST TRAINING PROGRAMME (BTP) PRIVACY POLICY	
CONTROLLER	<p>The Controller of the processing of your personal data is Olympic Broadcasting Services, S.L. (OBS), with trade register no. B83747691 and registered address in Calle Torrelaguna 75, 28027 Madrid.</p> <p>OBS has appointed a Data Protection Officer who can be contacted at dpo@obs.tv.</p>
PURPOSES	<p>The Broadcast Training Programme (BTP) is a legacy programme from the host broadcaster of the Olympic Games to the host country designed to provide students with a unique extracurricular experience. Participating students receive training directly from OBS professionals and acquire the necessary skills to potentially work in the broadcast of the Olympic Games.</p> <p>If you apply to participate in the BTP, your personal data may be used for the purposes described as follows:</p> <ol style="list-style-type: none"> 1. Provision of necessary information to our partner agency for them to carry out the selection process of the BTP participants 2. "OBS may make a reference to the university you indicated in the application form to confirm your status as a student at such university and by agreeing this policy you give consent to the possible transfer of your personal information from the university to OBS to the extent necessary for the aforementioned purpose." 3. Adjustment of the BTP to better fit for participants; and 4. Management of the logistical aspects of the BTP. <p>Note: OBS will not conduct any selection process of candidates which are considered eligible.</p>
TRANSFER	<p>Personal information collected by OBS will be kept confidential but, subject to the provisions of any applicable law, may be supplied to any agent, contractor or third party who provides administrative or other services to OBS in Japan who has a duty of confidentiality to OBS.</p>
LEGITIMATION	<p>The processing of your personal data is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.</p> <p>Your personal data shall be retained for the time required to fulfil the purposes above mentioned for which they have been collected and to determine possible liabilities arising from that purpose and the processing of the personal data.</p>
SECURITY MEASURES	<p>OBS has implemented the appropriate technical and organizational measures to prevent the alteration, loss, misuse, unauthorized processing and access, or theft of your personal data, taking into consideration the available technology.</p>
RIGHTS	<p>You may exercise your rights of access to, rectification, erasure, restriction, objection to processing and portability of your personal data at any given moment, and to the extent established by the applicable legislation.</p>
